    - Show entries Up.
  - o 144 Owner Codes related to animals.
  - o All class categories were UP Everywhere including Fiber and Youth.
  - o Futurity Lost 1,100.00 or 1,200.00 this year (about same as last year).
  - o Stalls Used 19 stalls in upper barn with still room to grow in barn area.
  - O Liz moving to a new job so she won't be there next year.
  - Even with the increase of entries this year the show was still finished by Noon on Sunday.
  - o Photos coming from Photographer.
  - Vendors already wanting to schedule for next year.
