2022 Gathering Update with Lisa Robinson:

- Live Streaming Options/Costs
 - Lisa reported that she had been speaking with Webcasting regarding covering the Gathering show for 2022. She also spoke with Walton's but they were \$1,000.00 more than other webcasting companies.
 - o Benefits of doing Webcasting for the show would be:
 - Excitement from Exhibitors and Llama Community.
 - Increase Exhibitor and Vendor Sponsorships.
 - Add legitimacy to Llamas with being in front of so many livestock people.
 - Free live but subscription afterwards to view.
 - Can run 2 rings at a time.
 - Microphone is tied to live stream to eliminate background noises and will definitely be a benefit for the auction.
 - Headset's for commentary.
 - Sponsors can be run across the bottom of screen.
 - Can have 2 logo's on screen at a time for featured sponsors,
 - Can run 30 to 40 second commercials. (MP4 format)
 - o Original Pricing is \$1,500.00 per Ring per Day with Friday being \$3,000.00 plus Mileage and Hotel rooms.
 - Our Pricing would be \$4,465.00 for 3 days plus Mileage and Hotel Rooms.
 - Set up would be on Thursday and tear down on Sunday afternoon.

- Motion was made by Mark to hire Webcasting to do 2022 Gathering Show and Seconded by Kyle. Unanimously Approved.
- Lisa's opinion on the rainy day fund needs for the Gathering
 - Lisa is in favor of supporting a few other shows but not go too far to where we get into a bind for money to cover the Gathering each year.
